Name of area: Miramichi (*all coverage should be within a 24 km diameter circle*)

Sky & precipitation: 100% cloud cover; no precipitation to light rain to heavy at times

Ground & water conditions: 0-15 cm snow cover; river partially frozen, some open areas; brooks open

Date: December 15, 2019, 8:30 am to 5:00 pm

Temp: 0 C to +9 C **Wind:** am: SE 22-27 km/h / pm: SW 30 gusting to 50 km/h

Total participants: 12 (6 field observers in 3 field parties, plus 10 persons at 8 feeders)

Total party hours: 20 (18 by car, 2 by foot)

Total party kms: 389.4 (386 by car, 3.4 by foot)

Instructions:

The mammal count can and should be done at the same time as the Xmas Bird Count in a circle 24 ms (15 mi) in diameter and should be conducted on one day between December 14th and January 5th.

Examples on how to fill out the sheet:

2, (T) 3 Snowshoe Hare = this means that 2 snowshoe hares have been seen but also 3 different set of tracks during the count day.

4, (E) 1, (H) 1 Eastern coyote means that 4 coyotes were seen but also 1 excrement and one was heard.

Please send all reports using one of the means at the bottom of page 2.

Totals: **18** individuals of **2** species on count day plus **2** additional species during count period.
